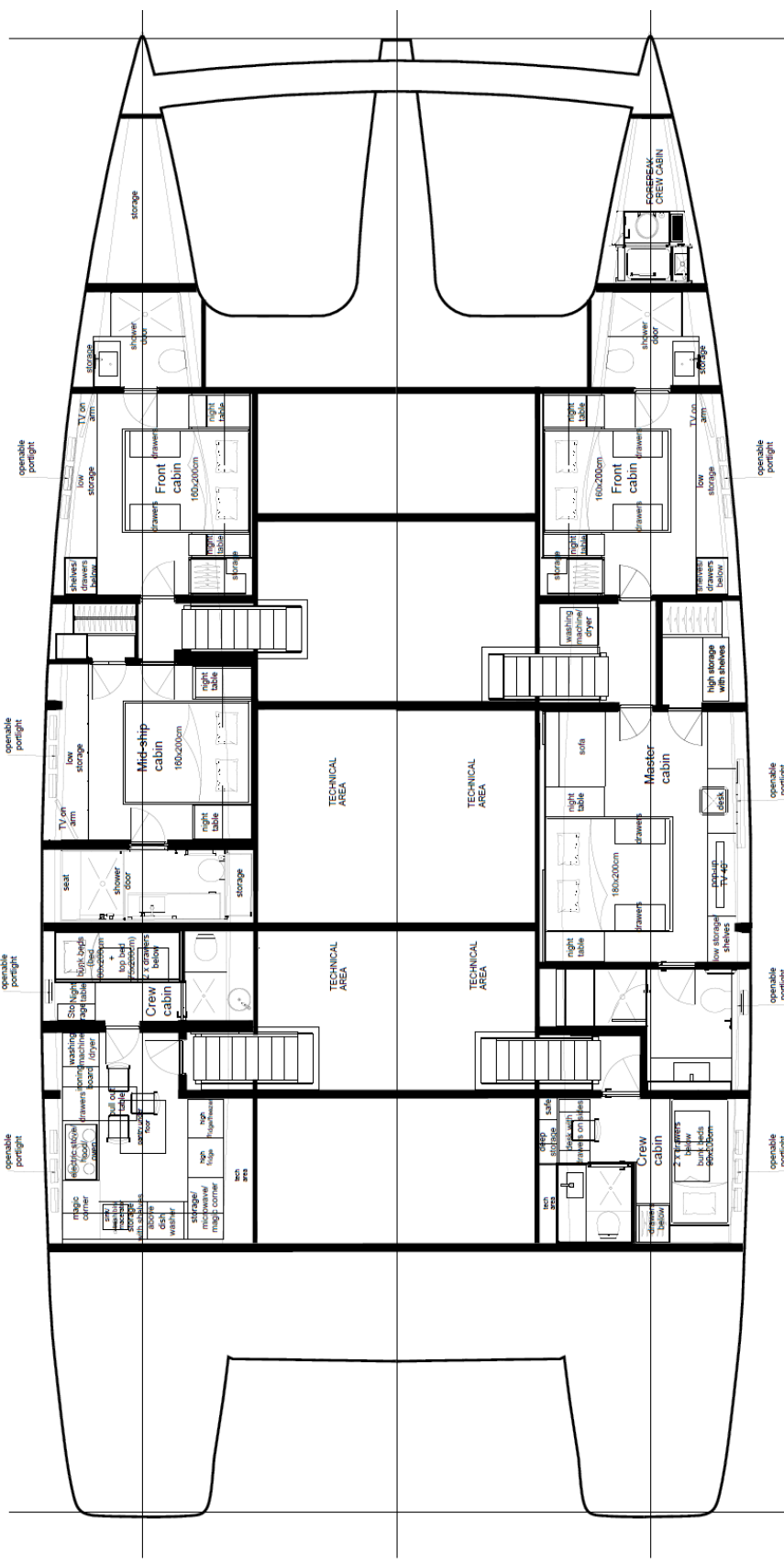

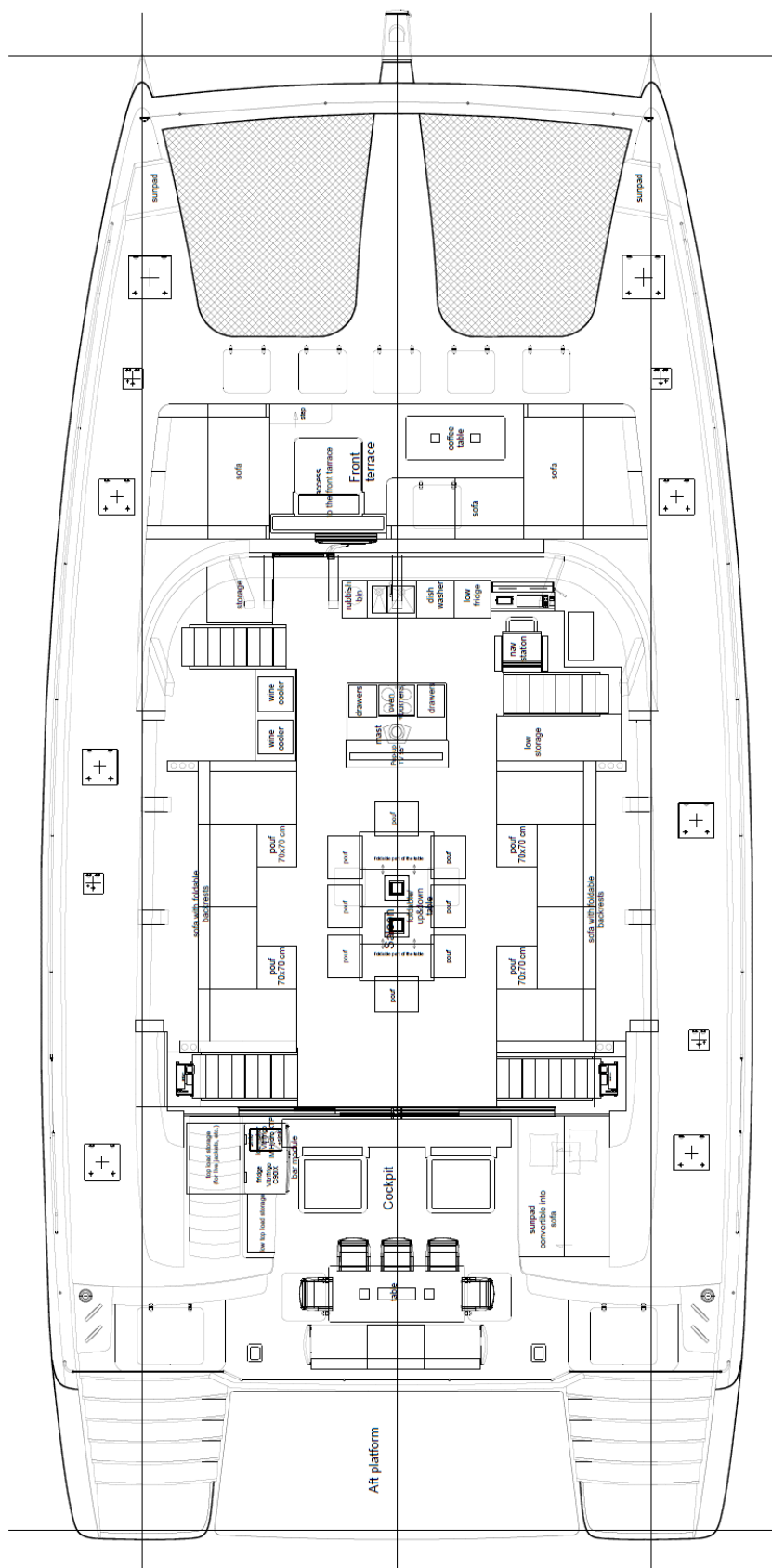

Layout Hull:



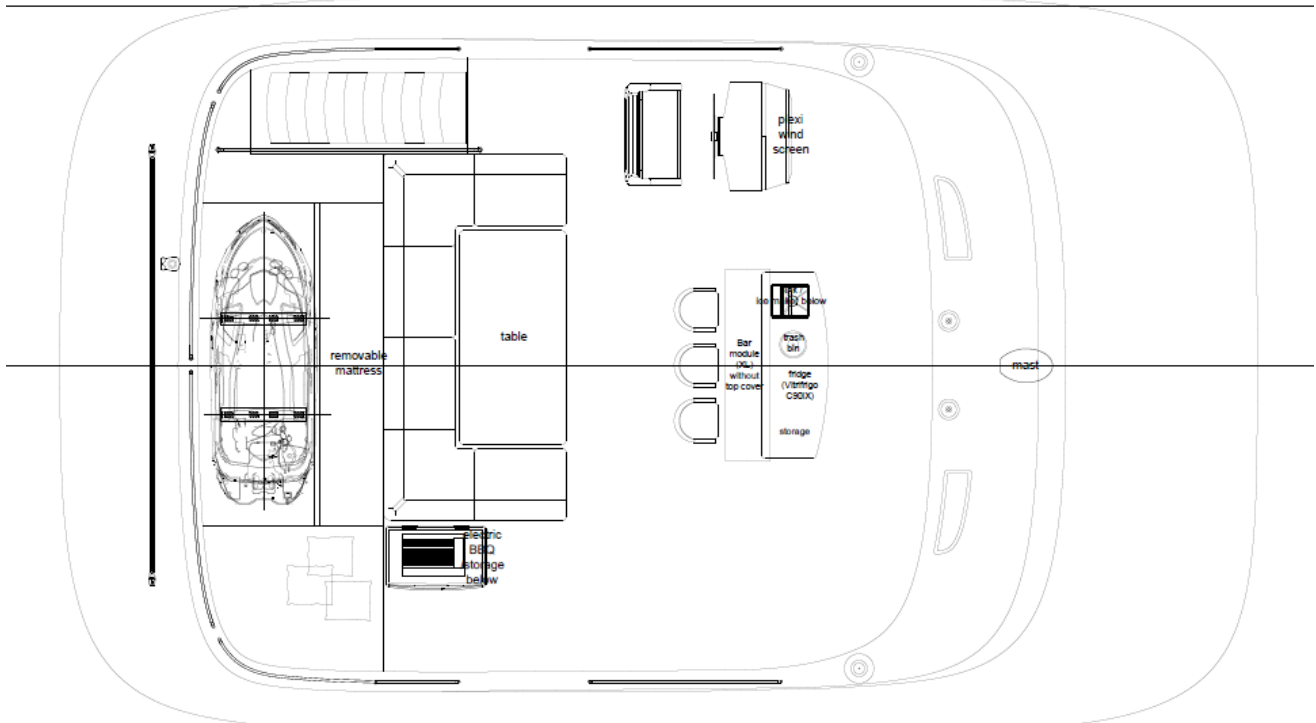
